Sanjay co-founded MIT's Auto-ID Center, a driving force behind the global EPC RFID standards. He co-founded OATSystems, acquired by Checkpoint Systems. He led MIT's team in establishing Singapore University of Technology and Design, serving on boards like Hochschild Mining and Aclara Resources.

With degrees from IIT, Carnegie Mellon, and UC Berkeley, he's worked at Schlumberger, Lawrence Berkeley Labs, and OATSystems. Research covers IoT, RFID, autonomy, cybersecurity, education, and more. An author of 3 books—The Inversion Factor, Grasp, and Workforce Education—Sanjay's contributions have shaped industries globally.

Melati Nungsari is an Associate Professor of Economics at the Asia School of Business and a Research Affiliate at MIT Sloan School of Management. Her expertise spans applied microeconomics, with a particular focus on industrial organization, public economics, market design, and economic education.

She holds a Ph.D. in Economics from the University of North Carolina, where her research delves into areas such as two-sided matching platforms, firm pricing strategies for addressing negative externalities, and important public policy concerns including refugee labor market integration. Nungsari's exploration also extends to retirement markets in Chile and Malaysia, labor market discrimination, and innovative approaches to economic education.

Having previously taught at Davidson College and Butler University, she boasts multiple teaching awards and is a member of Phi Beta Kappa. An avid Op-Ed contributor, her insights are published in esteemed platforms like The Edge Malaysia Weekly and the Chronicle of Higher Education. As a global speaker, she has presented her research across various international venues. Originating from Penang, Malaysia, her distinct background significantly enriches her academic contributions.

Dato' Zuraidah Atan, a dynamic Advocate & Solicitor, heads her firm, Chambers of Zuraidah Atan. Her educational foundation includes an LLB (Hons) from The University of Buckingham, England, and a Malaysian Qualifying Board Certificate in Legal Practice (CLP) with Honors in 1992. Further enhancing her capabilities, she pursued the Harvard Business School Executive Education Program "Making Corporate Boards More Effective" in 2013. She is also an alumna of Tunku Kurshiah College.

Throughout a distinguished three-decade career in banking and finance, Dato' Zuraidah has achieved remarkable milestones. Notably, she shattered barriers by serving as the President & CEO of Affin Merchant Bank (now Investment Bank), becoming a trailblazing female Bumiputera bank leader in Malaysia between 1999 and 2003. Her areas of expertise encompass cross-border transactions, spanning Corporate Banking, Finance, Capital Markets, and Corporate Debt Restructuring.

Dato' Zuraidah's influence extends to numerous boards, with her involvement commencing in 2004. These boards include HSBC Bank, Bank Rakyat, MBSB Berhad, Petron Malaysia, Northport (NCB Holdings Berhad), and various other Public Listed Companies (PLCs). Additionally, she has left her mark on the university boards of Universiti Utara Malaysia and Universiti Sains Malaysia.

Her professional journey features her retirement in 2022 from the Board of Kenanga Islamic Investors Berhad after dedicated service spanning over 11 years. In 2017, she fulfilled her role as a Public Interest Director of Bursa Malaysia Berhad, Bursa Malaysia Derivatives Berhad, and Bursa Malaysia Derivatives Clearing Berhad. Notably, she served two terms as an Independent Member for the Consultation & Corruption Prevention Panel of the Malaysian Anti-Corruption Commission (MACC).

Having concluded her tenure with S P Setia Berhad's Board Audit Committee after nine years, Dato' Zuraidah took on a significant role on the Board of Pengurusan Aset Air Berhad, an MoF Inc. company central to the restructuring of Malaysia's water services industry, effective May 11, 2023. In this capacity, she also holds the position of Chair for the Board Audit and Risk Committee. Additionally, she contributes her expertise as an Adjunct Professor at the UPM School of Business and Economics.

In her continued role as an advocate and solicitor, she actively participates in volunteer work. Presently, she is gearing up for her upcoming joint volunteer project: the PADI AWARE Dive Against Debris® and Beach Cleanup event scheduled for September 8th to 10th, 2023, at Long Beach, Pulau Perhentian Kecil, Terengganu.

Born in Perlis on July 25th, 1968, Dato' Sri Suriani graduated from Universiti Sains Malaysia (USM) in 1993 with a Bachelor's Degree in Communications (Honours). She later earned her Master of Arts in Strategy and Diplomacy from Universiti Kebangsaan Malaysia in 2006.
