# Faculty

**Professor Joseph Cherian** is Practice Professor of Finance at the Asia School of Business and at the Samuel Curtis Johnson Graduate School of Management at Cornell University (Visiting). He was most recently a Practice Professor of Finance at the National University of Singapore (NUS) Business School.

Prior to NUS, Joe was Managing Director, Global Head and CIO of the Quantitative Strategies Group at Credit Suisse in New York where he had direct responsibility for over US\$67 billion in client assets managed to a quantitative discipline. He was a two-term member of the Johnson School's Dean's Advisory Council and is now an Emeritus Member of the Council.

Joe has had appointments at Singapore's Central Provident Fund (CPF) Advisory Panel and the National Research Foundation's Early-Stage Venture Fund Evaluation Panel. He was an Independant Non-Executive Director of Bursa Malaysia, and a consultant to Fullerton Fund Management, a Temasek subsidiary, and Singapore Exchange (SGX) in Singapore. Joe holds a BSc in Electrical Engineering from MIT, and MSc and PhD degrees in Finance from Cornell University.

Joe is a HRD Corp certified trainer.

Jason Yap currently is the lead of the Academic Support team and an Instructor. He oversees the academic support operations and co-teaches Finance and Accounting. He holds a Bachelor of Commerce (Honours) and ACCA qualification. Prior to joining ASB, he worked as an auditor and a tax accountant in a multinational oilfield services company. Years later, he found his passion in education and joined a Leadership Development Program under Teach For Malaysia. Under the programme, he furthered his postgraduate study in education and taught in a public school, while launching several initiatives for the school and community.
